Location

The property is situated on Avenue Close, which is a development of small industrial warehouse units situated approximately one and a half miles north east of Birmingham city centre. Dartmouth Circus lies approximately a quarter of a mile to the west of the subject property and links to the A38(M) Aston Expressway, linking directly to Junction 6 of the M6.

Description

The subject property is an end terrace unit in a block of three units. The property is of a steel portal frame construction and is a mixture of brick and glazed elevations fronting onto Avenue Close and part brick/part profile steel elevations to the flank and rear elevations.

Internally, the building benefits from office accommodation at ground floor level, which is fitted out with suspended ceilings, integral lighting, carpeting, perimeter trunking and heating.

The warehouse element of the property benefits from a height to haunch of approximately 5.97 metres and is accessed via an electrically operated roller shutter door to a height of approximately 4.6 metres.

The unit includes 15 car parking spaces.
